Active—Any lawyer admitted to the bar of a state, territory, or possession of the United States and who resides in, or has his or her principal business office or place of law practice in Allegheny County.

Active Government—A government lawyer or judge is defined as a judge or lawyer who is employed full-time by a state, federal, or local government entity or agency or works full-time for a state, federal or local government entity or agency as an independent contractor. The lawyer also must be admitted to the bar of a state, territory, or possession of the United States and must reside in, or have his or her principal business office or place of law practice in Allegheny County.

Active Legal Services—A legal services lawyer is defined as a lawyer who is employed full-time by a non-profit legal services entity such as Neighborhood Legal Services, KidsVoice, Juvenile Court Project or who works full-time as an independent contractor for such an entity. The lawyer also must be admitted to the bar of a state, territory, or possession of the United States and must reside in, or have his or her principal business office or place of law practice in Allegheny County.

Associate—Any lawyer who is admitted to the bar of a state, territory or possession of the United States and who does not reside in, and does not have his or her principal business office or place of law practice in Allegheny County shall be eligible for associate membership. Associate members shall be entitled to the rights and privileges of active members except that associate members shall not have the right to vote or to hold office in the Association. An associate member may serve as a voting member of any committee of the Association, except the Judiciary and Nominating Committees.
