Active—Any lawyer admitted to the bar of a state, territory, or possession of the United States and who resides in, or has his or her principal business office or place of law practice in Allegheny County.

Active Government/Legal Service—A government lawyer or judge is defined as a judge or lawyer who is employed full-time by a state, federal, or local government entity or agency or works full-time for a state, federal or local government entity or agency as an independent contractor.

A legal services lawyer is defined as a lawyer who is employed full-time by a nonprofit legal services entity such as Neighborhood Legal Services, KidsVoice, Juvenile Court Project or a lawyer or judge who works full-time as an independent contractor for such an entity.

The lawyer also must be admitted to the bar of a state, territory, or possession of the United States and must reside in, or have his or her principal business office or place of law practice in Allegheny County.

Associate—Those eligible for Associate membership include any lawyer who is admitted to the bar of a state, territory or possession of the United States and who does not reside in, and does not have his or her principal business office or place of law practice in Allegheny County; any lawyer who is admitted to the bar of a state, territory, or possession of the United States, and who is not actively engaged in the practice of law but is still on active status with the Court and maintains a law license; any person who holds a JD degree from any ABA-accredited law school, but is not admitted to any court or bar of a state, territory, or possession of the United States or is on inactive status with the court. Persons in this category may include retired lawyers, law professors, or persons in other professions using their JD degree but not admitted to practice by any court.

Associate members shall be entitled to the rights and privileges of active members except that associate members shall not have the right to vote or to hold office in the Association. An associate member may serve as a voting member of any Committee, Division, or Section of the Association, except the Judiciary and Nominating Committees.

Emeritus Status—Those eligible Emeritus Status membership include any lawyer who has been approved for emeritus status in the state of Pennsylvania. As defined by Pennsylvania Rule of Disciplinary Enforcement 803, emeritus status attorneys are retired from the practice of law but seek to provide pro bono services to legal aid organizations. An Emeritus Status Member shall have the rights and privileges granted by the Board of Governors from time to time, except the right to vote or to hold office in the Association. An Emeritus Status Member may serve as a voting member of any Committee, Division, or Section of the Association, except the Judiciary and Nominating Committees. Emeritus Status members are entitled to up to 8 hours of free CLE credit each year.
